

Direct Services: API Chaya provides advocacy based counseling, support groups, safe housing alternatives, helpline, crisis intervention, legal advocacy and a resource referral for victims of domestic violence, sexual assault and human trafficking. In 2014, API Chaya provided case management to 246 survivors of domestic violence, sexual assault human trafficking and or other crimes. We fielded 3,018 phone calls through our helpline.

4b (Code) (Expenses \$ 218,629. including grants of \$ ) (Revenue \$ )

Community Organizing: API Chaya organizes leadership conferences, parenting classes and culturally appropriate education to community groups, engages the community through community events, leadership trainings and conferences, and parenting classes. In 2014, API Chaya's Community Organizing Program participated in more than 210 outreach activities including presentations, community street outreach, community tabling events, network meetings and advocacy events. API Chaya reached over 7,000 community members through its community outreach and education activities this year.

Anti-Human Trafficking: API Chaya provides services to victims of human trafficking, such as safe housing alternatives, resources for medical needs, advocacy, case management and legal advocacy. In 2014, API Chaya provided case management to 22 survivors of human trafficking. We continue to be a partner with King County's Crime Victim Service Center, Washington Anti-Trafficking Response Network, University of Washington Anti-Trafficking Task Force, and Washington Advisory Council on Trafficking.
