These two organizations joined with a common mission to be the region's center for hands-on science, arts, and cultural education for the "kids" in every stage of life. This mission is being accomplished through two efforts: Mobius Kids and Mobius Science Center. Mobius Kids is supported by businesses, schools, and residents throughout our community. In the last year, more than 65,000 children and families have benefitted from the hands-on arts, science, and cultural education that Mobius Kids provides.
