Training for parent and professionals with over 40 break-out sessions, including hispanic translation, multi-discipline, includes CE continuing education credits. Speakers and trainers are experts in their field, and include school teachers and university professors. Computer technology training brings in experts for professional tech groups nationwide, and research and university level experts on adaptive technology. All Born In project includes advocacy support. Content review and post training recaps and reports are produced to gauge quality and application of training provided.

General Education and Advocacy - Reciprocal Learning Community for birth to 5 year old training, health, diet, oral and motor skills, Open Arms - new parent groups for community building, clothing and resources, Hispanic outreach, leadership development, Development of Dream Builders and Think College programs. These programs key and related theme is the development of parents and their children in preparing for successful transitions, readiness, and secondary options for education. All programs are developed in conjunction with experts and professionals who work with NWDSA is developing content, process, support, evaluation, and expansion of projects from pilot stage to final project roll-out.

Outdoor/indoor events to build physical capacity and sucess - Buddy Walk outdoors at a sporting venue. Paents, professionals, friends, family come out to walk for their Buddy. Includes other physical play events and games. Includes opportunity to come together as community for public support. Food is provided for a per person fee. Speakers discuss disability issues.

Bike First - annual program to help children with intellectual and physical delays overcome balance and fear issues to learn how to independently ride a bicycle. The event is held annually and is conducted at Concordia University. Teen volunteers are key to the success of the event. The week program uses special bike technology and the equipment is rented for the event.
