To recruit and place adult volunteers into inner-city public elementary schools to read aloud one-on-one to children

28 Approximately 135 Volunteers read every week to approximately 240 students in five elementary schools of the West Contra Costa County, CA Unified School District. This is a relationship program designed to support young children's curiosity and joy in learning. An adult volunteer meets weekly to read to a child and listen to the child's questions and comments on the reading. Deep friendships are formed, and the child has the opportunity to discover the joys of reading and the love of books. Teachers select children to participate in the program, choosing those they think will benefit most from this individual attention, one-on-one reading, and exposure to books. Teachers end-of-year evaluations demonstrate that children thrive in the program. Read-Aloud is based on the SMART Program in Oregon. An independent study by the Eugene Research Institute reveals that children who participated in SMART are more likely to reach state reading benchmarks than are similar students who did not participate (fifth graders). In the 2014-15 academic year, Read-Aloud will have contributed approximately 3,000 reading hours to these children and provided more than 5,500 books to build children's home-libraries. Dr. Marilyn Nye, Professor of Education specializing in International Children's Literature and founder of the program stated, "This program is elegantly simple but a potent tool for literacy."
