Sponsorship of Oktoberfest festival modeled after the traditional annual Oktoberfest of Munich, Germany. This event attracts several thousand participants each year to the experience of an authentic Bavarian town.

4b (Code) (Expenses \$ 6,634. including grants of \$) (Revenue \$ 6,690.)

Sponsorship of Christkindlmarkt festival modeled after the traditional annual Christkindlmarkt of Nurnberg, Germany. This event separately attracts approximately 2,500 visitors to a wintertime Bavarian town experience.

4c (Code) (Expenses \$ 221,856. including grants of \$ 221,856.) (Revenue \$)

An agreement between Projekt Bayern and the City of Leavenworth was made on October 8, 2012 to secure the Fruit Warehouse as a permanent location for holding the Annual Oktoberfest Celebration for \$50,000. Coinciding with its mission to support the improvements and enhancements of the Old World Bavarian Theme, the organization also donated approximately \$171,856 to various organizations in the community. The most significant enhancement in 2014, was the rehabilitation and construction of restrooms at the local community Lions Club Park in downtown Leavenworth for \$124,176.
