In 2014, the Marsha Rivkin Center funded a total of 11 grants to U.S. organizations and individuals involved in ovarian cancer research. The awards were Pilot Study, Scientific Scholar, Bridge Awards and Challenge grants that focused on areas of research in dendritic cell vaccination & inhibition of tumor-associated immune suppression, ovarian cancer & pulp and paper manufacturing in the US, dendrimer-folate targeting of paclitaxel to ovarian cancer, specific targeting of Inhibin in ovarian cancers, single-cell molecular profiling of biopsies of epithelial cancer, a strategy to overcome drug resistance in ovarian cancer, targeted therapy for ovarian clear cell carcinoma, treating ovarian cancer with novel ecto-5'nucleotidase inhibitors, targeted disruption of ovarian tumor stroma to enhance penetration of therapies and lymphocytes, unraveling the oncogenic effects of amplified miRNAs in high grade serous epithelial ovarian cancer, copy gain and resistance uncovering roles for epigenetic regulation in ovarian cancer

The Marsha Rivkin Center for Ovarian Cancer Research was formed to stimulate and facilitate ovarian cancer research by organizing scientific symposia and education seminars, funding of promising pilot studies, improving the effectiveness and availability of early detection screening, providing educational and awareness building information on ovarian cancer to the public, and, raising funds to support and expand the organization's activities

In 2014, the Rivkin Center continued its effort to foster progress in the understanding and methodology of early detection screening through its Ovarian Cancer Early Detection Screening Program (OCEDP). OCEDP provided twice-yearly testing (CA125 blood measurement and ultrasound), collected and stored blood samples, conducted health status questionnaires, and administered genetic counseling sessions for 527 women from Washington, Oregon, Idaho, Montana, and Alaska. Additionally, blood samples and data was provided to researchers in their work to identify additional ovarian cancer protein blood markers and technologies to improve current screening standards
