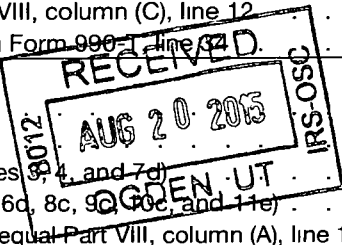

Siyafunda/Makalali

Siyafunda means 'To learn and to teach' in Zulu. These are the objectives on which Siyafunda Wildlife and Conservation was founded in 2004 and the basic principles that drive their projects. The aim is to obtain a greater understanding of wildlife and the environment in which it thrives and to teach the volunteers who come to help Siyafunda projects. Siyafunda was founded to assist the Greater Makalali Game Reserve with the monitoring of its elephant herds as part of a world-renowned elephant contraception research program. This evolved into research programs on all the Greater Makalali Big 5 animals as well as other predators.

In 2014 the Lion Foundation sent over 160 volunteers to Siyafunda including the Ivy Leaders and Broadreach school groups. These volunteers got classroom and hands-on training in the conservation of endangered species while assisting in the collection of research data on indigenous fauna. In addition, their contributions made it possible for Siyafunda to support the local Rekgathile Special Needs School and Holy Family Orphanage.

Project #2

Kariega

Kariega is a 10,000 hectare private Big 5 game reserve on the Eastern Cape of South Africa. Established 23 years ago Kariega has a lodge that caters to the wealthy who want a luxury Big 5 safari experience, but it also has a volunteer program supported by the Lion Foundation which allows people interested in conservation and game reserve management an opportunity to learn about conservation while doing the hands-on labor of the reserve and monitoring game and habitat through observation and the collection of data.

In 2014 the Lion Foundation sent 25 volunteers to Kariega. Their contributions included the monitoring of the impact on the habitat of the resident elephant herds, performing a lion-prey study, constant study of the leopard population and its movement, and the preservation of the resident rhino population. They also participated in a community outreach program at Farmerfield School. With the help of the Pack for a Purpose campaign, they gave the school about 10kg of supplies, including educational maps and posters, paint, crayons, pencils, exercise books, flashcards and sport equipment.
