Each year, the Foundation Secretary affirms in writing to the Orient SGIG (Scot. Rite state head) that all disclosures have been made.

In order to avoid any conflict of interest, the existence, including relevant details, of such financial interest must be disclosed to the Foundation. If the transaction involves a possible scholarship, the person with the conflict of interest may not serve on the Grading Committee while that application is being considered.
