Communications - The Association communicated via printed newsletters, email, website and social media about news including changes in law, opportunities for professional enhancement, and member accomplishments.

Health Care Reform, Wellness and Prevention - We participated in state and federal healthcare reform initiatives along with physician groups, policymakers and insurance companies. Much of the focus of healthcare reform is shifting the healthcare system from an acute care model to a wellness model. Early access to physical therapy is one of the interventions that will reduce downstream costs for surgery, medication and lost time at work.
