were not maintained. The cost, depreciated basis and value of those assets are now unknown. If required by the Internal Revenue Code of  
Regulations, the assets will be inventoried, appraised and balance sheet prepared.

**Part VI, Line 3** The organization has a Board of Directors who delegate management duties to a contracted System Manager.

**Line 6-8b** The organization is made up of Members living in the water system who elect the Board members. The Members hold an  
annual vote to approve the yearly budget. The Board Secretary takes minutes to document all meetings.

**Line 11 and 19** A copy of form 990 is provided via email to Board Members for review prior to mailing. the organization provides  
governing documents, conflict of interest policy or financial statements on request by Members.

**Section B, Line 12c** Board Members are queried annually at the board meeting following the Annual meeting as to whether they have  
any existing or potential conflict of interest. Each Board member signs a statement indicating the status of any existing or potential  
conflict of interest.
