EACH SITE IS LOCATED IN THE ELEMENTARY SCHOOL IN WHICH THE PARTICIPANTS ARE ENROLLED, CREATING CONSISTENCY FOR THE CHILDREN AND ELIMINATING TRANSPORTATION WORRIES FOR PARENTS. CAMP FIRE'S ALASKA'S SUMMER CAMPS PROVIDED NEARLY 2,800 CAMPERS WITH OPPORTUNITIES TO BE OUTSIDE, CONNECT WITH NATURE, LEARN NEW SKILLS, MAKE NEW FRIENDS, AND GET A SENSE OF LIFE THAT IS LARGER THAN ONE'S SELF. SUPPORTIVE GUIDANCE OR CARING ADULT COUNSELORS HELP CAMPERS BUILD THEIR OWN UNIQUE COMMUNITY. SUMMER CAMPING PROGRAMS ARE DESIGNED TO INCREASE SELF-AWARENESS, POSITIVE VALUES, SOCIAL SKILLS, ACCEPTANCE, APPRECIATION OF ONE'S SELF AND SENSE OF BELONGING AS WELL AS INCREASED KNOWLEDGE OF AND APPRECIATION FOR THE NATURAL WORLD. BECAUSE ALASKA CONSISTENTLY HAS MORE THAN TEN TIMES THE NATIONAL AVERAGE OF DROWNING INCIDENTS EACH YEAR, THE PROGRAMS INCLUDE BOATING SAFETY AND COLD-WATER SURVIVAL, HEALTHY LIFE CHOICES REGARDING NUTRITION AND DENTAL CARE AS WELL AS RECREATIONAL ACTIVITIES SUCH AS CRAFTS, GAMES, HIKES, CAMP-OUTS, AND YOUTH COMMUNITY SERVICE PROJECTS.
