Monitoring and identifying such situations is the responsibility of the individual, the President of the Board, and the Board as a whole. Monitoring and enforcement of compliance with policies as they relate to employees is the responsibility of the Cooperative's General Manager. Annually the Cooperative provides questionnaires to its Board of Directors, officers, key, and highly compensated employees. This provides a means to disclose and obtain detailed information regarding the individual relationships reportable personnel may have with the Cooperative's affiliates giving rise to a potential conflict of interest.

Compensation for the Cooperative's General Manager is set annually by the Board of Directors. This is discretionary based on performance to the extent it falls within the established range. This range is developed and reviewed every year based on averages and compiled from both industry surveys and information obtained from comparable utilities. Each such review is consistent in its inclusion of the relevant data. Compensation for managers and key employees is conducted in the same fashion, however, the decision is made by the Cooperative's General Manager.
