A portion of the dues payable to Leading Age are allocable to lobbying expenses, as disclosed above. Additionally, both Diane Gibson and Delores Sellner have served as board members for Leading Age Oregon. On rare occasions, Diane, Delores and others at Terwilliger have had direct contact with legislators to promote the interests of the long-term care industry. The members of Terwilliger Plaza have, from time to time, invited candidates and elected officials into the Plaza to speak. Terwilliger Plaza has a written policy related to those activities.
