THE RALPH D. & BUNNY SCHLESINGER FOUNDATION WAS CREATED CREATED THROUGH A BEQUEST IN THE WILL OF BERNICE SCHLESINGER THE ESTATE OWNED REAL PROPERTY, WHICH WAS SOLD IN 2012 TO ESTATE BENEFICIARIES. THE SALE WAS COMPLETED WITH THE ISSUANCE OF A PROMISSORY NOTE IN THE AMOUNT OF \$3,900,000. THE TRANSFER OF THE AFOREMENTIONED PROMISSORY NOTE TO THE FOUNDATION TO SATISFY THE BEQUEST TOOK PLACE ON 7/1/2013. THE FOUNDATION'S SUBSEQUENT TAX RETURN BEGINNING IN FISCAL YEAR 2013-2014 WILL REFLECT THE NOTE BALANCE ON THE FOUNDATION BALANCE SHEET AND WILL REPORT ANY INTEREST INCOME EARNED THROUGH THE NOTE.
