Plaza Project: The library is undertaking a multi-year project to revitalize covered space outside its main entrance. The space is currently dark and unattractive. Project completion is scheduled for late 2015 or early 2016, and will provide more light, library-themed decor, and places for people to meet or study. This year's expenditures were largely architectural fees for project design and planning.

Collection Enhancement: The Foundation purchased materials identified by the Library Director for patron use, including paper and electronic books for all ages, videos, periodicals, etc. Purchased approximately 715 items for the adult and 116 items for the children's collections, (\$10,961 and \$895, respectively).

Mosaic Project: As part of the Plaza Project above, the local Ford Family Foundation Leadership Group is sponsoring a statue with mosaic base, which should be complete in 2015.
