We develop tools, resources and analysis and provide training and organizational support to help groups and their constituencies advance policies and change hearts and minds. Our Gender Justice Program consists of two different cohorts: Uniting Communities and We are BRAVE. We work with organizations based in communities of color to be more inclusive of their members who are LGBTQ, and be able to take a public stand for LGBTQ rights through Uniting Communities. In 2014 we worked with a dozen partner organizations from Nevada, Oregon and Washington to elevate their work at the intersections of racial and gender justice. The Center brought partners together four times over the course of the year for training, peer learning, and collaboration, resulting in a first ever collaborative digital campaign for National Coming Out Day.

Our annual leadership development conference, Activists Mobilizing for Power, moved from being an annual event to being every other year. In our cohorts above, Uniting Communities and We are BRAVE, fundamentals of community organizing are woven throughout the programming.	
4c	(Code) (Expenses \$ 100,561 including grants of \$) (Revenue \$ 70,010) The Research and Action for Change and Equity (RACE) Program supports organizations building power in communities of color, immigrant and refugee groups and communities in addressing vital racial justice issues. In 2014 we released Facing Race: Oregon Legislative Racial Equity Report Card, which we coordinated with six community-based organizations and was endorsed by over 30 community organizations. The report card is a concrete tool that enables communities in Oregon to hold their elected officials accountable to their constituencies. The Center also worked with several organizations to deepen the work of racial justice as a part of their organizational programming, culture and mission.
