We accomplish our mission through research, public education, and the advocacy of environmentally sound public policy toward the goal of building just and sustainable human communities that provide for people and the natural world.

Conservation advocacy for marine biodiversity and the resilience of Oregon's coastal communities. 2014 continued our coastal marine conservation work with the hiring of Jim Carlson as a community organizer in support of Oregon's marine reserve system. Jim's work also supports resilient coastal fishing communities through education about marine stewardship. 2014 marked a transition to supporting the state of Oregon in the implementation of its nearshore marine reserve network. Our work is coordinated with the Oregon Marine Reserve Partnership, of which, we are a member. Our major program efforts involved support for the creation of Oregon Marine Reserve Partnership and groundwork to form two community-based groups supporting reserve implementation for the Cascade Head Marine Reserve and the Cape Falcon Marine Reserve.

4b (Code:) (Expenses \$ 21,166 including grants of \$ 0) (Revenue \$ 23,769)
Public lands management for the protection of native forest and the conservation of aquatic ecosystem values such as native salmon and clean water. Our major accomplishment was the publication of an independent science report authored by ten of the Northwest's leading aquatic science experts. Dr. Chris Frissell was lead author. Titled CONSERVATION OF AQUATIC AND FISHERY RESOURCES IN THE PACIFIC NORTHWEST: Implications of New Science for the Aquatic Conservation Strategy of the Northwest Forest Plan, the report has been downloaded from the CRA website over 1,000 times. The report was sent to key scientists, managers, and staff at the USDA Forest Service and the Oregon Bureau of Land Management (BLM). In addition, our Public Lands Program provided input to ongoing land management planning by the BLM and initial efforts at plan revisions by the Forest Service. A key aspect of our work was researching and understanding the guiding 2012 Planning Rule that will direct forest planning for all federal national forests. We also provided staff support to the Newport, OR base Oregon Coast Community Forest Association during the first quarter of the year.
