IT OFFERS INDIVIDUAL LOCAL THEATER ARTISTS (ACTORS, DIRECTORS, AND PLAYWRIGHTS) THE OPPORTUNITY TO FOLLOW A DREAM AND CO-PRODUCE A PLAY FOR WHICH HE OR SHE HAS A SPECIAL PASSION. COHOS ARTISTIC COUNCIL, COMPRISED OF PROMINENT THEATRICAL SCHOLARS AND WORKING THEATER PROFESSIONALS, REVIEWS DOZENS OF PROJECT SUBMISSIONS TO SELECT A SEASON COMPRISED OF THE THREE PLAYS WHICH REPRESENT THE HIGHEST DEGREE OF ARTISTIC EXCELLENCE. WHILE THE CHOSEN ARTISTS ARE RESPONSIBLE FOR BRINGING THEIR ARTISTIC VISION TO LIFE ON THE STAGE, COHO PROVIDES THE FUNDING AND THE VENUE, AS WELL AS MARKETING AND ADMINISTRATIVE SUPPORT.
