Credit and Housing Education and Counseling: CCCS of SF delivers comprehensive financial wellness programs. In 2014, CCCS of SF helped 18,673 families take charge of their personal finances. Free workshops helped to teach sound personal financial skills, the wise use of credit, and the essential issues of home buying. Over 165 workshops were delivered with 4,023 individuals in attendance. To ensure education was available for all those in need, 19 online education modules were offered allowing consumers the convenience of accessing financial and credit education in a digital format from a computer or mobile device; 94,959 self-study online financial modules were completed. CCCS of SF's toll-free hotline provided 148,836 consumers with immediate answers to questions about credit reports, credit scoring, wage garnishments, student loans, identity theft, and other credit-related matters. To help those facing foreclosure, over 10,000 counseling sessions were conducted for foreclosure alternatives, and another 14,000 sessions were conducted for foreclosure prevention.

Credit Counseling, Financial Fitness & Debt Management Services. Consumer Credit Counseling Service of San Francisco (CCCS of SF) provides comprehensive one-on-one counseling to individuals and families on a wide range of money management and credit related issues involving budgeting, debt management, retirement planning, improving credit, and other credit related matters. About 15 percent of these counseling sessions result in the consumer choosing to participate in an individually customized debt management plan. Participants make one monthly payment, in an amount negotiated with the creditors, to CCCS of SF, which is then distributed to the creditors. In 2014, over 5,500 families are repaying their debt through the debt management plan of CCCS of SF. Over 37 million dollars in debt were repaid through this program in 2014. CCCS of SF also provides education and counseling services to employees and/or members of sponsoring organizations via the Financial Fitness Program. Education programs include in person workshops and online webinars supported by one-on-one counseling.
