The National Judicial College (NJC) receives funding through the U.S. Department of Justice (its cognizant agency), U.S. Department of Transportation; and the State Justice Institute in support of training and research projects addressing the administration of justice and the rule of law. During 2014, NJC designed programming, publications, and websites, provided technical assistance to the justice community and conducted educational programs including the Tribal Web Based Course for Court Administrators, Justice Leadership Symposium, Enhancing Court Efficacy Through Emerging Addiction Science, A Systems Change Approach, Tribal Court Development 2, Fundamental Considerations for Tribal Court Professionals, FMCSA National Webcast, Commercial Driver Licensing Enforcement, Designing & Presenting Programs Effectively, A FDW, Commercial Driver's Licensing Law for ALJ's. Additionally, the Departments of Justice and Transportation help support attendance at tuition-based courses by supporting participant travel costs when state and local funding is unavailable.

The College conducts courses for judges, court personnel, mediators, and others who perform quasi-judicial and administrative functions in the justice community. Course participants come from all 50 states, U.S. territories, and numerous foreign countries. The range of programs is extensive, including new judge training, mediation, administrative law programs, family law and tribal court programs. Courses deal with both civil and criminal law and are held on-site at the College on the campus of the University of Nevada, at locations around the country and via the web. Through its programming NJC works to improve judicial knowledge, court administrative skills, productivity and to inspire judges to achieve judicial excellence. Among the courses offered in 2014 were: Logic and Opinion Writing, Conducting the Trial, Judicial Writing, Judicial Philosophy and American Law, Domestic Violence, Consumer Credit Litigation from A to Z, What Judges Need to Know, Effective Use of Courtroom Interpreters - WEBCAST for Judges, Child Custody Challenges, Evidence and Orders. The College's tuition-based courses are just one of the ways that NJC supports its mission "to provide leadership in achieving justice through quality judicial education."

In addition to providing tuition-based education courses, The National Judicial College provides custom designed judicial education programs to meet the individual needs of the court systems, associations, state judicial education bodies and administrative law agencies throughout the country. Some of the programs that NJC created and presented during 2014 were 21st Century Technology for Judges, Handling Capital Cases for Las Vegas District Court Judges, Financial Statements in the Courtroom, Essential Fair Hearing Techniques for the U.S. Department of Agriculture, Judicial Writing for the EPA's Environmental Appeals Board, DUI Basics for Nebraska Judiciary, Judicial Writing and Communications for the Board of Parole Hearings. The College also conducted program, faculty development and distance learning workshops for individual state administrative offices of the court and training centers to assist them in providing quality education programs.

The National Judicial College's special and innovative programs address current and emerging issues confronting judicial systems and provide participants with in-depth knowledge and skills to effectively manage these issues in court. This year's agenda included programs on the neuroscience of substance abuse disorders, best practices for conducting administrative hearings for administrative law judges, and training designed to improve procedural justice in a criminal-court setting. The College also presented in-state conferences focusing on human trafficking awareness and a program to help judicial officers adjudicate complex water cases.
