The Hospital de la Familia Foundation is a 501(c)3 organization based in San Francisco, California that supports a 72-bed hospital, as well as educational and wellness programs in the rural town of Nuevo Progreso, in the Department of San Marcos, Guatemala, serving approximately 20,000 low-income patients per year HDLFF coordinates missions of volunteer medical teams specializing in general surgery (in 2014 performed 220 consultations/169 surgeries), plastic surgery (145/103), OB/GYN (146/56), ear, nose and throat (259/45), ophthalmology (2063/521), optometry, dentistry, pediatrics (45/0), and audiology HDLFF also funds year-round clinics at which 9570 consultations were done by the resident Guatemalan doctors of the hospital, and which include 1) a nutrition center for malnourished infants and toddlers which treated 34 children, who stayed between a month and 11 months, 2) a grade-school for girls and boys, which enrolled 162 children (grades 1-6) and from which 27 6th graders graduated, 3) a nursing school in which 36 students were enrolled and from which 23 graduated in 2014 and received their diplomas as medical assistants, and 4) a sewing school which enrolled 12 women and girls of whom 9 graduated
