Eligible low-income persons, via local governmental and nonprofit organizations, can receive financial assistance to offset the costs of heating and/or cooling dwellings, and/or have their dwellings weatherized to make them more energy efficient. This is accomplished through these program components: \*The Weatherization Program provides free weatherization services to improve the energy efficiency of homes, including attic insulation, weather See Form 990, Page 2, Part III, Line 4a (continued)

The U.S. Department of Energy (DOE) Weatherization Assistance Program (WAP) provides funding and technical assistance to state and territory energy offices to help them advance their clean energy economy while contributing to national energy goals.

The purpose of WAP is to increase the energy efficiency of homes owned or occupied by low-income persons, reduce their total residential expenditures such as heating and cooling bills, and improve the health and safety of families.
