Valuescience—offered "Valuescience: Shedding Illusion to Live Better" at Stanford University spring and autumn quarters and at Magic summer and autumn quarters; presented valuescience to more than five hundred individuals at Magic and in business, school, and other community settings (e.g., San Francisco Art Institute; Branner Hall, a Stanford student residence with a public service theme). Residential Education: twenty-two interns and affiliates from throughout the US, and from Asia, Europe, and South America participated for one to several months; fifteen were accepted for longer stays; Resident Fellows provided interns and affiliates more than one thousand hours of guidance in living in valuescience-based service learning community.

Cooperation & Individual Well-Being—Liveable City: hosted 35th annual Evergreen Park Neighborhood Association picnic; continued a vendor donation program through which we collected and processed twenty-five tons of food surplus from the California Avenue Farmers' Market for use in programs of Magic and of Community Services Agency, a local organization that serves low-income clients. Planning for Living: delivered quarterly two-session seminars with weekly follow-up for three months to fifteen Magic service-learning community residents. Movement Magic: provided one hundred hours of swimming, running, cycling, and other somatic awareness instruction to residents and to twelve clients from beyond the Magic residential service learning community. Creating Loving Community: provided one hundred hours of consultation to persons inquiring about living in intentional community. A Better Home - hosted eighty-five MIT Alumni Club of Northern California members and guests on one occasion and one hundred Passive House of California Association members and guests on another occasion for a lecture by building scientist Allen Gilleland and building tour; hosted more than two hundred interested parties on dozens of other occasions for building tours.

Environmental Stewardship—Planting for the Second Hundred Years: engaged 700 volunteers diverse in age and background; partnered with a half-dozen high and middle schools, Stanford alumni, Stanford service dorm, Stanford Tzu Chi, Stanford Alpha Phi Omega, Stanford Women's Gymnastics, Santa Clara University Engineers without Borders, SAP Corporation, Google, and other groups whose participants contributed more than 2,100 hours of volunteer service. With their labor they nurtured 600 seedling oaks and other native trees in Magic's on-site nursery; transplanted 50 young oaks and 90 other California native trees, shrubs, and vines into publicly accessible open space; monitored and nurtured 2,000, and hand-watered 400 previously planted oaks and other California natives growing on open space used by 600,000 visitors annually.
