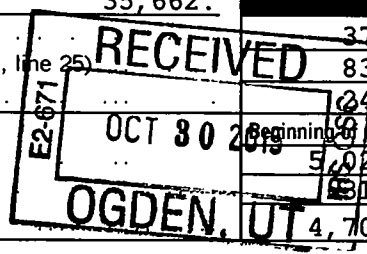

The mission of the Smith River Alliance is to provide for the long-term protection, restoration and stewardship of natural resources in the Smith River watershed.

Salmonid Restoration Program: Smith River Alliance, California Department of Fish and Wildlife and the Forest Service are collaborating on surveys to assess and monitor Coho salmon and complete stream habitat research. Coho Surveys: Coho salmon are listed as "endangered" through the California Endangered Species Act and "threatened" through the Federal Endangered Species Act. Data on the distribution and abundance of Smith River coho salmon will help fisheries biologists better understand factors limiting the successful spawning, rearing and survival of this species. And by better understanding the limiting factors for coho salmon survival, fisheries scientists gain critically important insights about limiting factors for the spawning, rearing, and survival of ALL salmon species in the Smith River.

4b (Code:) (Expenses \$ 99,650. including grants of \$) (Revenue \$)

General Program: SRA works to protect and restore critically important landscapes and habitat within the Smith River watershed. An example project is securing permanent protection of the Hurdygurdy Creek watershed located in the heart of the Smith River National Recreation Area (SRNRA). The project includes several miles of Wild and Scenic River corridor -- including along Hurdygurdy Creek, a significant spawning and rearing tributary for coho, Chinook salmon, and steelhead. SRA owns and manages the 115-acre Rock Creek Ranch on the South Fork Smith where school groups and others gather to learn about wild rivers, natural resources, and off-the-grid sustainable living systems. SRA secures funding for high priority habitat restoration projects basin-wide to improve the natural productivity of wild salmon, steelhead, and trout.

4c (Code:) (Expenses \$ 80,985. including grants of \$) (Revenue \$)

Mill Creek Program: SRA has been a partner with Redwood National and State Parks on a suite of integrated restoration projects across the 25,000-acre Mill Creek acquisition area which was added to Del Norte Coast Redwoods State Park in 2002. SRA is working to improve the structural and biological diversity of the Mill Creek watershed through restoration activities that include road removal, ecological forest thinning and the installation of instream wood structures. The Mill Creek Program presents extraordinary challenges for maintaining and restoring wildlife and fish populations. The legacy of decades of intensive industrial timber operations threatens the ecological integrity of the natural systems that support Mill Creek's wildlife and fisheries.

Additional program accomplishments: SRA is a leader in the CA campaign to block a proposed strip mine in the headwaters of the Smith and Illinois Rivers.

The Smith River is one of the "crown jewels" of the National Wild and Scenic River System and the last major undammed river in California. Over 300 miles of the Smith are included in the National Wild and Scenic River System, created in 1964 to "protect outstandingly remarkable scenic, recreational, geologic, fish and wildlife, historic, cultural or other similar values, for preservation in a free-flowing condition."

SRA is also a partner with Redwood National Park in the development of a trail from Jedediah Smith Redwoods State Park to the community of Hiouchi. SRA launched a public education and interpretive initiative for the Lake Earl Wildlife Area. SRA continues to work to safeguard the important habitat at the Lake Earl Wildlife Area.

The watershed exemplifies the biological diversity of the Klamath/Siskiyou bioregion. Its floral diversity supports a rich assemblage of mammals, birds, reptiles, and fish including black bear, mountain lion, wolverine, northern spotted owl, Chinook and coho salmon, steelhead, and coastal cutthroat trout.
