Leftovers Inc generated funds from its thrift store by selling contributed clothing and household items. Donations were then made on a monthly basis to Contra Costa Crisis Center, and on a periodic basis to the local Food Bank and Meals on Wheels, both of which operate county wide programs. In 2014 the program gradually raised its contribution to the Crisis Center from \$6,000. to \$10,000. per month.
