Our largest offering here is our biennial Facing Race Conference, described below. In addition to the Conference, we trained approximately 1,350 individuals through live trainings in 2014, with additional people accessing our webinars. Approximately 900 activists have also downloaded our racial equity impact assessment tools online.

Facing Race National Conference - Our biennial conference is the country's largest multiracial, inter-generational gathering for organizers, educators, and creatives.
