We support 14 Device Lending Libraries, Reuse Centers and 28 Independent Living Centers throughout the state. We provide funding, training, and technical assistance to a network of over 1500 organizations and individuals. We developed the Freedom Tech Alternative Finance Program, which will offer low interest and guaranteed loans to people with disabilities seeking loans for Assistive Technologies in 2015.
