LESBIAN HEALTH FUND - ONE OF GLMA'S MOST IMPORTANT PROGRAMS IS THE LESBIAN HEALTH FUND (LHF), WHICH MAKES DIRECT GRANTS TO FUND LESBIAN HEALTH RESEARCH, THE WORLD'S ONLY RESEARCH FUND SOLELY DEDICATED TO THE UNIQUE HEALTH NEEDS OF LESBIANS AND SEXUAL MINORITY WOMEN. IN 2014, LHF AWARDED GRANTS TOTALING NEARLY \$30,000 TO 3 DIFFERENT PROJECTS FOR LESBIAN HEALTH RESEARCH.
