CAFF helped to pass legislation to change the fees and operations of certified farmers' markets. This allows urban gardens to sell produce to the public and requires basic food safety practices of all direct market farms and farmers' markets.**4c (Code) (Expenses \$ **976,135.** including grants of \$) (Revenue \$)**Community Impact: Food for your Family****CAFF's Farm to School program educates students about healthy eating through farm field trips, in-class lessons, and our Harvest of the Month (HOTM) program. HOTM delivers produce to school classrooms so that teachers can take the lead with food and farming education, and students can taste fresh produce from local farms. During the 2013-4 school year, we reached over 36,000 students per month! We offered farm field trips and assisted school food staff with procurement. Schools purchased over \$600,000 of produce from local farmers during the year because of our work.**
