


IN 2014, NORTHWESTERN POLYTECHNIC UNIVERSITY EXPENDED \$169,123 IN OCCUPANCY EXPENSES WHICH PARTLY GENERATED REVENUE OF \$1,543,398. THIS REEVENU WAS A COMINATION OF TUITION REVENUE AND DORM AND FACILILTLY RENTALS. THIS OCCUPANCY EXPENSE CONSISTED OF EXPENSES TO MAINTAIN AND OPERATE THE BUILDING ON THE CAMPUS AND RENTAL REAL ESTATE PROPERTIES. THESE BUILDINGS WERE WHERE INSTRUCTIONAL CLASSES IN SESSION, ADMINISTRATIVE OFFICES AND COMMUNITY FACILITYH RENTALS, ACTIVITYH LOUNGE AND DOMITORY ROOMS FOR STUDENT WERE LOCATED. EXPENSES TO MAINTAIN THE BUILDINGS WERE SUCH AS: REPAIR AND BUILDING MAINTENANCE, JANITORISL AND PEST CONTROL SERVICE, UTILITIES EQUIPMENT RENTAL, COMMUNICATION, AND SECURITY.

THE OTHER PROGRAM EXPENSES INCLUEDE FOR NORTHWESTERN POLYTHCNIC UNIVERSITY INCLUDED THE COMPENSATION FO OFFICERS, DIRECTORS, AND KEY EMPLOYEES. THIS COMPENSATION ENABLE THE NORTHWEWTERN POLYTECHNIC UNIVERSITY TO PROVIDE A UNIQUE EDUCATIONAL CULTURE AND LEARNING EXPERIENCE ENVIROMENT FOR STUDENTS, SUCH AS KEEPING UP WITH FAST PACE CHANGES IN TECHNOLOGY AND BUSINESS. WITH THESE ORHER PROGRAMS EXPENSE THE UNIVERSITY MADE SURE THAT EACH PROGRAM WAS DESIGNED OF STUDENTS TO ACCOMPLISH SPECIFIED GOALS AND CONTRIBUTE TO COMPETENCE IN THE SUBJECT AREA. IN SHORT, THES PROCESSES ENABLED THE THE UNIVERSITY TO PROVIDE STUDENTS WITH A REWARDING EDUCATIONAL EXPSERIENCE.
