Refugee Transitions is a community-based nonprofit agency serving high-need, low-income refugee, asylee, and immigrant newcomers from over 50 countries. Based in the San Francisco Bay Area, RT provides education, family engagement, and community leadership programs that help newcomers become self-sufficient and successful in their new communities. A key component of our work over the last 30 years has been fostering cross-cultural relationships between receiving and newcomer communities.

RT's vision is to see all newcomers thrive and become full, participating members of our shared communities. Our mission is to assist refugee, asylee, and immigrant newcomers in becoming self-sufficient in the U.S. by providing services that help them attain the English language, life, job, and academic skills they need to succeed in their new communities. We believe in the power of education to unlock opportunity, and we provide solutions that are transformative for students and volunteers alike. We are honored to share in the journeys of our students and firmly believe that refugees, asylees, and immigrants have the resiliency and leadership potential to shape our world for the better.

RT's three program areas can be visualized in three concentric circles. At the core, we provide education and enrichment programs, including home-based tutoring/mentoring, after-school programs, summer camps, adult English language classes, and parent classes that break down social and linguistic isolation for individual newcomers, and provide a bridge to self-sufficiency. We have developed a strong volunteer recruitment, orientation, training, and support system to not only increase our reach and impact in the community but also to provide a framework for the development of cross-cultural relationships and shared experiences between

receiving and newcomer communities. The personal contact is significant in reducing isolation for our students and often, we hear back from our volunteers stating that they have benefited more from the partnership than their students. In the next circle, we provide family engagement programs that lift up entire families, connecting them with vital human services and helping them to access other support services, and community resources. Finally, we provide community leadership training for refugee and immigrant youth leaders/peer tutors, and adult community navigators, building their capacity to help their own communities, support future newcomers, and multiply the effect and reach of our work. Within these concentric circles of programming, we also remain nimble in order to respond to emerging needs based on global events and changes in migration patterns.

In 2014, RT employed a team of 10 staff members and 20-30 contract instructors. Also integral to our team was our dedicated corps of 223 community volunteers who provided home-based and site-based tutoring throughout the Bay Area, focused primarily in Alameda, San Francisco, and Santa Clara Counties. In 2014, we served 1,750 unduplicated high-need, low-income refugee and immigrant newcomers from 52 countries. Of the 1,750 newcomers, 1,341 received intensive, ongoing services (measured by the number of times each participated in a program). This number does not include the additional family members who also benefited from having a tutor visit the home on a weekly basis. In total, RT provided 62,327 hours of education, family engagement and community leadership services, with an average of 46 hours per participant in 2014.

Most of our students come to the U.S. after having experienced significant violations to their human rights, including genocide and war crimes, having fled

war, violence, and economic hardships, grown up in refugee camps, and/or lost loved ones. At RT, we prioritize providing a safe space for our clients to heal, connect, learn, grow, and create better paths forward. With all of our clients being non-English speakers, some who are illiterate in their primary languages, and most who have interrupted or no prior formal schooling, we provide the bridge of language and social connections, as well as academic and life supports so that our clients not only access education and other community resources, but also excel. This includes customized curriculum for our clients that lead to English language gains, school success, and pathways to jobs and citizenship.
