

Education of Clergy-Through the travels of its pastoral team to visit parishes and present seminars, through media broadcasts and publications and through regular one-on-one consultation given to priests around the world, the Priests For Life, Inc. pastoral team continued to educate and equip priests, deacons and seminarians to effectively proclaim the pro-life message and compassionately counsel those tempted to have abortions and bring healing and forgiveness to those who have already had abortions. In particular, the liturgical resources and homily hints, in English and Spanish, continue to be provided in print, on You Tube channels, and through a smartphone app. These liturgical resources cover every Sunday of the three-year liturgical cycle.

Frank Pavone in the production and taping of various episodes of Defending Life, and Teresa Tomeo and Astrid Bennett Gutierrez joined Janet for the Catholic View for Women. Our internet program Pro-life Straight Talk also continued and was expanded.

1-Closing of abortion mills-We have continued to work with Operation Rescue and Life Dynamics to close abortion facilities by collecting information on the unlawful practices that occur daily in these facilities and bringing them to the attention both of state agencies and also of the employees of these facilities, warning such employees that they too can face legal trouble if they do not blow the whistle on the illegal practices that they notice in these facilities. Some 73 abortion facilities in the United States were shut down in 2014.

2-ProLifeCentral.com-Over the last twenty years Priests For Life, Inc has developed a large amount of pro-life educational material and utilized it around the world. This year, along with developing new educational tools, we have re-organized and re-deployed our educational mission through a new website, ProLifeCentral.com. Along with this site, which have included an online university that combines the wisdom and experience of many leaders in the pro-life movement.

3-Pain Capable Unborn Child Protection Act-Priests for Life, Inc. will continue in the coming year to provide strong educational and practical support for the Pain Capable Unborn Child Protection Act, a measure that protects unborn children after 20 weeks due to the child's capacity to feel pain.

4-Pro-life Leadership Coalition-In 2014, Priests For Life, Inc. developed the "Pro-life Leadership Coalition," through which we will continue, as we have done in the past, to convene meetings and retreats both private and public, conference calls and webcasts at strategically valuable times, to bring pro-life leaders together to work in unity.

5-HHS Lawsuit Project Continues-Priests For Life, Inc. was the fourth group to launch a federal lawsuit against the "HHS Mandate". Having had oral arguments last Spring, a three-judge panel of the US Court of Appeals for the District of Columbia Circuit issued an adverse ruling in November 2014. We are now appealing to the full court, and will, if necessary, appeal to the US Supreme Court as well.

6-Parliamentary Network for Critical Issues-Under the umbrella of "Gospel of Life Ministries" we have continued to assist in the operation of the Parliamentary Network for Critical Issues. In 2014, PNCI continued its international outreach sharing best pro-life practices, responding to requests for assistance, and sharing information on the United Nations. PNCI continued to meet with lawmakers, religious leaders, and pro-life leaders from around the world; to network with pro-life leaders, legislators, and staff on ways to obstruct efforts to include abortion in development aid. PNCI continued to alert its network to the latest pro-abortion actions and strategies through special email alerts, updates and a monthly newsletter and through its membership on 5 pro-life Google groups, including 3 international groups. The PNCI website was maintained with the latest news and headlines affecting a culture of life around the world. Priests For Life, Inc. (PFL) prepared submission statements presenting PFL's pro-life, pro-child, pro-mother, and pro-family position to various US commissions and prepared PFL handouts for delegates. Collaborating with other pro-life NGOs, PNCI helped to advance support for the culture of life at the UN.

7-National Day of Remembrance for Aborted Children-In conjunction with two other national organizations, Priests for Life, Inc. sponsored the National Day of Remembrance for Aborted Children on September 13, 2014. At approximately 40 different gravesites throughout the U.S. where tens of thousands of aborted children are buried, simultaneous memorial services are held on that day. Leading up to this observance, educational efforts focus people on how these burial places came to be, how the babies were found and how they were killed in the first place

8-Prayer campaigns-We continued our campaign to mobilize believers to pray each day for an end to abortion. We did this by means of a daily prayer to end abortion, and at special times, by means of seasonal prayers and novenas. The prayer website www.PrayerCampaign.org as well as the Facebook cause www.ProLifePrayers.com provide the faithful with specific pro-life prayers related to liturgical seasons, pro-life feasts, and other significant occasions. The prayers are made available in English and Spanish. We also made available prayer cards for certain of these occasions throughout the year.

9-Selma and Juneteenth Under the leadership of our full-time director of African-American Outreach at Priests For Life, Inc, Alveda King, niece of Martin Luther King Junior, we conducted Pro-Life Freedom Rides in 2010, modeled on the activities of the Civil Rights Movement. Now, modeling our activities again on the Civil Rights Movement, we went to Selma, Alabama, and walked across the Edmund Pettus bridge as was done 50 years ago in favor of voting rights. We did this on the 150th anniversary of Juneteenth, and focused on the specific problem of the lack of state regulation of abortionists and their facilities.
