Educational Outreach. Through books, videos, lectures, reports, conferences, classes, interviews and web-based materials, we inform the public of the many costs of globalization, and the systemic benefits of economic localization. Community screenings of our documentary film, *The Economics of Happiness*, provided opportunities for ISEC staff to speak in person or via Skype to audiences across North America, Europe, Australia, and New Zealand. ISEC Director Helena Norberg-Hodge also had extensive speaking engagements in Australia, Europe, Asia, and North America. We also continued with our *Roots of Change* study group program, which gives people the opportunity to join with others in their community to follow a guided curriculum that outlines the root causes of our many crises, and systemic solutions.

4b (Code:) (Expenses \$ 67,471 including grants of \$ -0-) (Revenue \$ 33,619)

Economics of Happiness. This program includes our documentary film, *The Economics of Happiness*, as well as an ongoing series of International Economics of Happiness conferences. In 2014 we held a public conference in Bangalore, India that drew more than 1,000 participants. The conference was preceded by an intensive 2-day meeting among nearly 100 activists from South Asia and beyond. We also began planning for an Economics of Happiness conference in Portland, Maine, to be held in 2015. The film was translated and subtitled in several more languages, including Greek, Russian, and Ukrainian.

Laakh Project. During 2014 we continued our efforts of the past 35 years to counter unsustainable development in this Himalayan region. We conducted Global to Local workshops in Leh, the capital of Ladakh; screened relevant documentary films and conducted post-screening discussions; created a new 'Eco-Map' of Leh, showing tourists where to find local food, local handicrafts, etc.; organized farm stays for Learning from Ladakh participants; and helped organize and run a Traditional Skills workshop.

However, the campaign was not as successful as we hoped, and the balance raised (\$13,120) is being held until the Board determines that the funds should be devoted to some other purpose, or that we should mount another fundraising campaign to increase the endowment's size. In the meantime, interest on these funds are being used to support ISEC's ongoing work.

Specifically, the UK£ was worth US\$1.6488 on January 1, but fell to US\$1.5532 on December 31. The Australian \$ started the year US\$0.88727, but was down to \$0.81562 by year's end.
