THE JUNIOR GIANTS PROGRAM WAS ESTABLISHED IN 1994 AS THE FUND'S FLAGSHIP PROGRAM AND CURRENTLY SERVES OVER 23,000 BOYS AND GIRLS, AGES 5 TO 18 IN MORE THAN 87 COMMUNITIES THAT SPAN ACROSS NORTHERN CALIFORNIA, OREGON, AND NEVADA. THE PROGRAM RELIES ON OVER 2,200 VOLUNTEERS AND STAFF MEMBERS TO RUN THE NON-COMPETITIVE LEAGUES. THE FUND PROVIDES ALL OF THE UNIFORMS, EQUIPMENT, AND TRAINING NECESSARY TO RUN A LEAGUE AS WELL AS TICKETS TO SELECT SAN FRANCISCO GIANTS GAMES FOR THE YOUTH TO EXPERIENCE MAJOR LEAGUE BASEBALL. THE PROGRAM FOCUSES ON THE FOUR BASES OF CHARACTER DEVELOPMENT - CONFIDENCE, INTEGRITY, LEADERSHIP AND TEAMWORK.

THE FUND RECOGNIZES THE IMPORTANT ROLE THAT EDUCATION PLAYS IN THE LIVES OF YOUTH AND OFFERS NUMEROUS PROGRAMS THAT REACH OUT TO STUDENTS, TEACHERS, AND EDUCATIONAL ORGANIZATIONS. PROGRAMS INCLUDE THE HARMON AND SUE BURNS SCHOLARS FOR COLLEGE SCHOLARSHIPS TO EIGHTH-GRADERS PARTICIPATING IN THE JUNIOR GIANTS PROGRAM, THE ROUND THE BASES READING PROGRAM, AND EDUCATION DAY AT AT&T PARK. THE FUND ALSO PROVIDES GRANTS TO EDUCATIONAL NONPROFIT ORGANIZATIONS.

THE FUND'S FIELD RENOVATION PROGRAM IS NAMED IN HONOR OF PETER MAGOWAN FOR HIS LEADERSHIP IN BUILDING THE GIANTS ORGANIZATION AND ITS COMMUNITY OUTREACH OVER 16 SEASONS. THE PETER A. MAGOWAN FIELDS FOR KIDS PROGRAM REACHES OUT TO UNDERSERVED COMMUNITIES WHERE THE JUNIOR GIANTS PROGRAM EXISTS IN ORDER TO ENHANCE RECREATIONAL OPPORTUNITIES AND CREATE SAFER PLACES TO PLAY. THE PROGRAM INCLUDES THE FULL RENOVATIONS OF UP TO TWO FIELDS EACH YEAR WITH PLANS TO FACILITATE A SMALL GRANTS PROCESS TO ASSIST WITH UPGRADES SUCH AS A NEW BACKSTOP OR FRESH SOD FOR THE INFIELD. SINCE 1995, THE GIANTS COMMUNITY FUND HAS WORKED WITH GIANTS PLAYERS AND PARTNERS SUCH AS THE GOOD TIDINGS FOUNDATION TO REFURBISH MORE THAN 23 YOUTH BASEBALL FIELDS.
