APEN mobilized local allies and community members to speak out against the Chevron Richmond Refinery expansion project. Chevron was compelled to include measures for improved risk management and work safety measures and reduction of harmful pollutants, as well as agree to pay community support benefits. APEN planned and put on the four-day Our Power National Convening in Richmond to bring together 450 low-income frontline community members from throughout the country. APEN staff members presented workshops and participated in panels, plenaries, and strategy discussions. We conducted outreach at Contra Costa Community College.

4b (Code:) (Expenses \$ 294,679. including grants of \$) (Revenue \$ 2,500.)State Program

APEN educated decision-makers about innovative policy solutions to ensure the reduction of greenhouse gas production and air pollution and promote clean energy use in California. New laws include renewable energy incentives for low-income communities, initiatives for clean energy community choice, programs to increase the number of electric cars and trucks, and mandates to decrease climate pollution caused by methane and black carbon. The state budget allocated nearly \$300 million in Greenhouse Gas Reduction Fund monies for low-income community priority projects: affordable housing, public transit, urban forestry, renewable energy, and energy efficiency. APEN organized statewide outreach and education workshops to enable frontline communities to access this new source of climate solution funding.

APEN facilitated nearly 70 events for our 800-person grassroots membership base. We provided civic engagement and education, issue-debriefing, food, transportation, and interpretation into multiple languages at every event including Khmu, Mien, Cantonese, and Mandarin. Key events included the annual Leaders' Retreat and six-week APEN Academy. APEN and its members educated decision makers and the public about the need for community benefits to be included in the Lake Merritt BART Station development plan.

APEN mobilized nearly 20,000 Asian Pacific Islander (API) voters through multilingual pre-election outreach, town hall meetings, voter education and guides, in-person canvassing, and phone banking. We collaborated on an API Voter Guide, translated it into six languages, and distributed it to 3,172 voters. Of those we spoke with, 85% made firm commitments to vote on election day in November. Locally, APEN put on nonpartisan Candidate Forums in connection with key races in Oakland and Richmond. APEN engaged allied organizations, encouraged the participation of all candidates, invited the media, and facilitated participation of our own grassroots API membership base.

Communications & Network

APEN was invited to participate in, and provide leadership for, climate justice, grassroots organizing, civic engagement, and policymaking endeavors. These included Oakland Rising (the multilingual, multiracial collaborative mobilizing voters in

Oakland), California Environmental Justice Alliance (CEJA), and more. Several APEN staff members traveled to New York City to participate in the historic Peoples Climate March. An APEN staff member was one of seven people who spoke to the crowd of over 400,000 before the march began. We developed culturally appropriate spokesperson training curriculum to enable APEN and our members to increase our presence in mainstream and ethnic media outlets, and online social networks.
