Our programs and services engage young students in powerful learning across the curriculum by helping teachers and scientist and engineer volunteers plan and implement exciting STEM learning experiences that take advantage of the wealth of local science, engineering, and environmental education resources.

Teacher Services: CRS provided over 1,300 Kindergarten through 8th grade teachers with comprehensive information, references, personalized support, web-based resources, training, workshops, and other support related to science teaching and learning. CRS served classroom teachers in 125+ schools in the East Bay, including Oakland, Emeryville, Berkeley, and West Contra Costa. CRS provided teachers with on-call planning support, custom research reports, and responded to over 1,000 individual teacher requests. CRS provided workshops addressing science and engineering teaching practices and curriculum to in-service teachers and pre-service teachers. Together, the teachers we serve educate over 25,000 students, mainly in high-need, urban, under-resourced public schools. More than 100 teachers successfully completed the Science Super Star Challenge designed to recognize, highlight, and reward teachers and schools who exemplify excellence in science teaching and learning. Monthly newsblasts and quarterly resource reports are archived and accessible to teachers on the CRS website.

Bay Area Scientists in Schools (BASIS): The BASIS program recruited, trained, and placed over 500 STEM professionals into Kindergarten through 8th grade classrooms to present engaging, standards-based, hands-on science lessons. Scientists and engineers serve as diverse, enthusiastic role models who inspire young students to learn about academic and career options in science and engineering. Scientist volunteer teams presented over 450 lessons in classrooms in 2014, engaging over 10,000 students in science learning activities. The lesson plans and related material resource information, science content background, and teaching strategies are made available to classroom teachers hosting BASIS team visits, encouraging pre-visit and post-visit explorations, investigations, and design challenges to extend the learning. The lesson materials are also archived and accessible to teachers and BASIS volunteers on the CRS website.

Research and Resource Development: Research, convening, consulting, and training projects targeting specific science education topics. CRS provided professional development and curricular development services to schools, districts, and informal education organizations. CRS coordinated site-based pilto projects involving middle school science support linking scientists with middle school teachers and students. The CRS Advisory Council on Elementary Education brings together thought leaders from industry, academia, school districts, informal education organizations, scientists and engineers, and others working to improve the quality of K-8 science education.
