(28) Nonprofit Board of Director's development, training workshop to familiarize members with Hale Mua's vision; policies; nonprofit board job description, responsibilities and their role as Directors.

(29) Hale Mua and the Committee of 2014 King Kamehameha Day Celebration Parade with HTA did plan, promote, and conduct a parade that honors the legacy of King Kamehameha; Ho'olaulea festival; and a Pau'u workshop. . Targeting a large audience of visitors and the general public, committee was able to have more participants in the floral floats; cultural exhibits and displays. Admission was free and opens to the public.

(30) Hale Mua and the Royal Order of Kamehameha I, Moku O Mamalahoa members with HTA carried out planning, promoting the festival mission: (1) honor the memory of King Kamehameha; (2) Perpetuate the Hawaiian Culture, hula; music; oli (chant) and cultural practices, arts, and crafts with Hawaiian practitioners sharing their knowledge. Several thousand island residents and visitors attended the event. The Kamehameha Festival is free to the public and remains an alcohol and smoke free event.

(31) Hawaiian Tourism Authority Grants of \$17,500 for each event was contracted and signed by Hale Mua's CFO.
