The goals of Strong families are to Change the way people think about, feel about, and act in support of families of all kinds, Build strong alliances across social justice sectors to expand the initiative's base of power, Change policy on the local, state, and national levels to benefit the majority of families and, Mobilize communities to take action for issues impacting families facing the greatest challenges and discrimination.

Youth Organizing Develops the leadership of 60 young Asian women and men in Oakland, CA to advocate on behalf of their communities. In addition to the overall leadership development goals of the program, Forward Together Youth leads the "Sex Ed the City" campaign, which works to ensure that public schools implement a comprehensive sex education curriculum that is culturally sensitive and inclusive of LGBT students, immigrant students, and youth of color.

Strong Families Communications Leads campaigns to shift the attitudes and minds of individuals, as well as mainstream culture around issues impacting families. Major media campaigns include Mamas Day, which brings visibility to the mothers in our community who often go unrecognized and are stigmatized for not conforming to traditional narratives of motherhood in mainstream society. With an email list of 20,000 supporters and a social media presence totaling approximately 14,000 followers, Forward Together engages with diverse communities online and through traditional media to transform culture and policy.
