 The Farm Opportunities Loan Program provides flexibly structured financing to underserved, low-income, immigrant and beginning farmers across the state for operating, equipment and infrastructure loans The average loan size is currently \$27,000 FarmLinks loan program serves borrowers who would otherwise have a difficult time securing financing due to limited history as entrepreneurs, limited traditional collateral, limited or no credit history, small loan size required, language barriers, and non-traditional marketing and business models FarmLink also directs farmers to other appropriate alternative sources of financing suited to the scale and type of the farming business FarmLink's Lending Program has closed 42 loans in 2014, totalling \$1,200,000 80% of the loans have gone to Latino growers, and 80% are annual operating loans These funds have helped retain 178 jobs and helped create 46 jobs

 Our Land Access Program maintains a FarmLand Listing database of land available for lease or sale, connects farmers and landowners, helps them develop and negotiate strong leases, and supports farmers seeking financing for land purchases Succession planning workshops help farm families pass farming businesses and assets to the next generation Since 2011, FarmLink staff have developed 135 successful leases or purchases tailored to the needs of landowners and growers Personalized advisory services (technical assistance) In 2014, FarmLink staff provided hours of technical assistance to over 325 growers and landowners 65% of this assistance supported low-income farmers Educational events In 2014, California FarmLink staff conducted 23 educational events attended by over 500 growers Events included Farmland Lease Clinics and Farm Finance Expos, which bring together a wide variety of farm lenders and farmer, through collaborations with farmer training programs such as the Agricultural and Land-Based Training Association (ALBA) and the California Farm Academy at the Center for Land-Based Learning

 FarmLinks agricultural Individual Development Account (IDA) program, or matched savings program, was the first of its kind in the nation and was the inspiration for a farm IDA program authorized in the 2008 Farm Bill FarmLinks IDA program allows limited resource farmers to build equity by putting money each month into a savings account and having that money matched by FarmLink and other partners at a ratio of 3 1 or 2 1 Farmers receive training in financial management during the program and at the end of the savings period, the money may be used to buy a farm asset such as a tractor or irrigation equipment, or to put a down payment on land
