National Programs: 2014 National program expenditures funded our national campaigns and programs, from organizational support for state affiliates, to policy advocacy, to national educational campaigns. A few highlights were our national conference of state affiliates in Washington DC, a new Certified Cool Congregations program, increased social media presence, and the launch of the "Paris Pledge" to mobilize congregations to commit to cut their emissions and inspire international action at the UN climate conference in Paris in 2015. We reached 72,000 people on our email list and 18,000 congregations, representing over five million people of faith.

2014 Re-grants to state affiliates:
The next largest portion of our program expenses was distributed in support grants to state affiliates. State IPLs educated their congregations about global warming and advocated for clean energy alternatives to coal, advocated for renewable energy incentives, fuel standards, and new EPA standards for power plants.

2014 California IPL:
California Interfaith Power & Light (CIPL) educated its congregations about global warming and advocated for equitable and effective climate policies at the state level. Highlights for the year included a reformatted "Cool Climate Awards" event honoring 15 congregations for their accomplishments saving energy and utilizing clean energy, increased resources to help congregations be energy and water efficient, and several events focused on engaging and supporting vulnerable and disadvantaged communities.
