## AMENDMENT TO DECLARATION OF TRUST

This Amendment to Declaration of Trust (this "Amendment"), effective as of September 5, 2014 (the "Effective Date"), is made by the undersigned, constituting all of the trustees (collectively, the "Trustees") of the Stephen A. Wynn Foundation, B.T. (the "Trust"), to amend that certain Declaration of Trust, dated January 15, 2000, as amended from time to time (the "Declaration of Trust").

1. Name of the Trust. Effective as of the Effective Date, the name of the Trust is hereby changed to "The Vision Foundation".

2. Confirmation of Existing Trustees. Stephen A. Wynn and Steven Dezii are hereby confirmed as constituting all of the Trustees of the Trust as of the Effective Date.

3. Effect on the Declaration of Trust. Except as specifically amended hereby, all other provisions of the Declaration of Trust, including, without limitation, any and all exhibits and schedules thereto, shall remain in full force and effect and are hereby ratified and confirmed in all respects.

4. Severability. In case any one or more of the provisions contained herein shall for any reason be held to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provision of this Amendment, but this Amendment shall be construed as if such invalid, illegal or unenforceable provisions had not been contained herein.


5. Governing Law. This Amendment shall be governed by and construed in accordance with the internal laws of the State of Nevada without giving effect to any choice or conflict of law provision or rule (whether of the State of Nevada or any other jurisdiction).
