LCMC provides support and management services to the System Entities so that the entities in turn can focus their efforts on carrying out their exempt purposes. To that end, the executive management of the System and their support staff and systems are centralized at LCMC. The revenue of LCMC is derived from management fees received from the System Entities. Children's Hospital and its subsidiaries, Touro Infirmary and its subsidiaries, and University Medical Center Management Corporation are members of the System (LCMC). While Children's and Touro are both tax exempt organizations, some of the affiliates and/or subsidiaries of Children's and Touro are for-profit entities. Any services provided to such entities will be at the express direction and for the benefit of Children's and Touro.
