The authors and presenters at Life Model Works continued to create, refine and present methods, written materials, presentations and web content. Thousands were introduced to the relational skills through the dissemination of training materials and in person training opportunities. This includes 2378 national and international conference attendees in California, Illinois, Texas, Florida, Nebraska, Washington DC, Hawaii, North Carolina, Canada and Chile. 249 students in online classes and webinars for leaders, pastors and community providing ministry training and education in addictions, healing, Christian formation and relationships. The audiences of 5 radio broadcasts. Couples were taught the relational brain skills in Joy Rekindled Marriage Weekends. Five-day Thrive training events were held in the U.S. Provided prayer and consultation to individuals, couples and groups. Provided training and consolation for missionaries.
