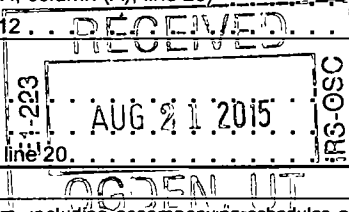

 Golf for Greenville was developed and founded by Fluor employee volunteers in 1989. Since its inception, this employee-led initiative has had a strong impact on the Greenville community. Countless volunteer hours go into organizing the tournament and soliciting donations. Recent years' Golf for Greenville events have had overwhelming support from Fluor employees and vendors, and frequently sell-out the tournaments. In 2014, a total of \$475,000 was donated from the Golf for Greenville bank account to the Boy Scouts of America Blue Ridge Council and the Urban League of the Upstate.

4b (Code _____) (Expenses \$ 407,020 including grants of \$ 306,920) (Revenue \$ 361,132)
 Fluor Cares team in Sugar Land, TX coordinates an annual golf tournament with Fluor Executives, clients and vendors which raised funds for five (5) non-profit organizations: 1) Texas Center for the Missing; 2) Lunches of Love; 3) Camp Victory; 4) His Grace Foundation; and 5) Texas Sentinels. Funding for the Grants was raised through tournament fees, tournament dinner, and silent auction.

4c (Code _____) (Expenses \$ 76,774 including grants of \$ 3,784) (Revenue \$ 73,895)
 Building Futures is an annual community outreach project in which Fluor Cares teams provided backpacks filled with school supplies to schools and youth organizations benefiting children in grades K-5. Fluor employees donated supplies and money to fill backpacks and provide classroom supplies. 100 backpacks and school supplies and \$1,319 cash grants were donated to Dallas and Irving, TX public schools, benefiting a total of 550 children in the Dallas area. 971 students were provided with school supplies and backpacks were provided to every child at West Cliff Elementary in Berea, SC as well as some to communities in Schools and the Boys and Girls Club. Over 1,300 backpacks were distributed to three schools in the Houston, TX area, along with receiving \$488 to be used for STEM related activities. 1,000 backpacks were filled and provided to Boys & Girls in southern CA, impacting 2,250 children.
