Through a small grants program we seek to support programs or projects aligned with our cornerstone programs and focus on education + literacy, sports + recreation and health + wellness. Grants typically range from \$500 - \$15,000.

Dodgers Dreamfields. The Dodgers Dreamfields program is one of the Los Angeles Dodgers Foundation's cornerstone programs under its Sports + Recreation pillar. The goal of the Dodgers Dreamfields program is to provide baseball and softball fields where youngsters can learn the game of baseball in an organized program that is administered by the City or County in a safe environment while learning the importance of playing team sports and key characteristics like sportsmanship, ethics and fair play. As of December 2014, the Los Angeles Dodgers Foundation had completed 36 fields, with a long-term goal of completing 50 Dreamfields.

Dodgers RBI is a comprehensive, urban youth baseball program for boys and girls, ages 5-18. Dodgers RBI was built on the joint pillars of LADF, offering youth the opportunity to learn and enjoy the games of baseball and softball, while also emphasizing education, recreation and healthy habits for young people. LADF provides 4,000 girls and boys uniforms and equipment, recruitment assistance, supplemental marketing assistance, cash grants for umpires and field maintenance, coach clinics, special events and tournaments. Education and health resources are also offered.
