Nectandra Institute's mission is to promote the conservation of the montane cloud forest ecosystems of Costa Rica through public education, scientific research and watershed stewardship.

Community Outreach and Education Program: Outreach and education efforts were directed primarily to the rural communities of Costa Rica's upper Balsa River Watershed. Nectandra Institute worked closely with a consortium of local community water management associations on efforts aimed at improving protection for the watershed's forests and water resources, including co-organizing and sponsoring the 7th annual "New Culture of Water" Month. The purpose of this annual multi-day event is to raise public awareness for watershed protection through a series of educational, recreational and entertainment events during the month of September. Approximately 36 educational activities were carried out during the year on topics related to conservation, ecology, and environmental stewardship. Educational videos, images and other information were shared with the public on local television and via online social networks.

4b (Code:) (Expenses \$ 29,518 including grants of \$ 0) (Revenue \$ 0)

Conservation and Advocacy Program: Nectandra Institute provided eco-loan financing to assist a group of water management associations with the acquisition of 21 acres of land formerly used for grazing cattle. The forest on this property will be restored in order to improve protection for local flora and fauna, as well as water resources for a nearby community of 3000 people. Overall, Nectandra Institute has helped our community partners in acquiring more than 560 acres of land, increasing the protection for the sources of drinking water for 16,000 people through forest conservation and restoration. During 2014, we coordinated more than 2500 person-hours of restoration and monitoring work, including tree plantings, measuring tree growth, monitoring volume water flows from springs and streams, and systematic photo-documentation of restoration progress over time.

Research and Citizen Science Program: Monitoring stream water quality at 24 different sampling points within the upper Balsa River watershed through microbiological laboratory analysis as well as analysis of the types of aquatic macroinvertebrates found at the various stream sampling points. Began a new project to monitor amphibians in and around the watershed. Members of the local public participate by taking pictures of frogs and other amphibians sighted in the geographic study area and submitting the images to Nectandra Institute. Nectandra Institute staff identify the amphibian species and maintain a database of all sightings. Results are shared with the public on an interactive, online map that is continuously updated with new records of sightings.
