Re-Entry Housing Program: During 2014, A New Way of Life Re-Entry Project (ANWOL)
was able to serve 67 women and 14 children through our re-entry homes for less
than half the cost of incarceration. On average, over 7 out of every 10 women who
received our services were able to meet annual benchmarks identified as crucial to
make successful community re-entries and 88% were not re-incarcerated. We were
also able to serve over 400 formerly homeless individuals through our household
goods distribution center.

Re-Entry Legal Clinic: ANWOL's Employment Rights Re-Entry Legal Clinic provides a
range of pro bono services for formerly incarcerated individuals. Services assist
clients with overcoming barriers to employment in order to promote successful
community reentries. Staff and volunteer attorneys provided services through 12
clinics for 260 individual clients. Staff attorneys filed 759 post-conviction
relief petitions. Petitions filed with known outcomes resulted in a 78% success
rate.

All of Us or None-Southern California (AOUON-SC): All of Us or None (AOUON) is a
national grassroots community organizing effort that works to reverse the
discriminatory policies and practices affecting formerly incarcerated
individuals. ANWOL houses the Southern California Chapter of All of Us or None,
(AOUON-SC) which consists of chapters located in Los Angeles and Long Beach. During
2014, we mobilized allied organizations and over 200 individuals to participate in
civil rights advocacy campaigns.
