Disater relief January Manado Flood Disaster ReliefOn January 15, 2014, flash floods and landslides in Manado, North Sulawesi caused at least eighteen deaths, and more than 40,000 people were displaced, according to the National Disaster Mitigation Agency World Harvest created a relief effort in order to help aid and assist those who were in need April Leadership Seminar in Kyenjojo, UgandaIn April 2014, World Harvest team went to Kyenjojo, Uganda for a computer seminar, leadership seminar, and life skill training Nepal Medical Mission 2014WorldHarvest embarked on a medical mission trip to rural Nepal in order to relieve some of the injustices inflicted by poverty We provided free medical assistance, free medications, and opened up health seminars to educate the people about proper hygiene The country of Nepal remains one of the most poverty-stricken countries in the world The unpurified drinking water, inadequate (or nonexistent) healthcare system, and lack of proper hygiene make the Nepalese living conditions extremely harsh Our team visited the rough lands once again from June 5th to the 14th World Harvest held similar health seminars and distributed medications to hundreds of people They listened intently on how to keep safe from certain preventable diseases caused by walking barefoot or by not washing their hands India Mission TripSimilar to our previous trips to Nepal, WorldHarvest invested in a mission trip to Northeastern India with the leaders of IFGF Church This trip lasted from June 10th to June 13th It was WorldHarvests first time performing humanitarian works in India The mission began in Bagrakote, Dooars Our team of 50 leaders and volunteers were able to reach out to about 4,000 people by the time World Harvest reached Silguri World Harvest held special leadership seminars to equip the community leaders and pastors and even interacted with the crowd of about 1,500 common citizens A total of 210 community leaders were educated and empowered to enrich their respective communities Our mission trip to India was indeed a powerful one Thousands of people received the education and the equipment that they needed in order to better their lives Indonesia Mission TripOur volunteers traveled to Indonesia this summer to hold the No Apology Seminar for both middle schools and high schools They traveled from June 23rd to July 5th, visting places in Central and Northern Sulawesi The No Apology Seminar teaches kids about the value of self worth and safe sex Because sex education is almost nonexistent in these parts of the world, the topic of sex oftentimes becomes taboo Kids are forced to learn from experience or from each other when it comes to getting sex education This leads to an alarming rate of unwanted pregnancies and even STDs Our team of certified educators came to local high schools and middle schools in Lakeya to interact with the students About 50 students were present at each seminar and they all responded positively to the interaction! Along with the No Apology Seminars, World Harvest also hosted free medical services in the communities that we visited Dental services, physical examinations and the distribution of free medicine were among the things offered at our medical tents Plenty of families reported their gratefulness to our volunteers and we felt exactly the same towards them July Sierra Leone Amputee Soccer Players in Los AngelesIn July, World Harvest invited Amputee soccer players all the way from Sierra Leone to share their peace message to the schools and local communities Instead of becoming bitter or giving up from their circumstances, they trained themselves to be really good and fast soccer players, travelling around their country to inspire other war victims to take charge of their lives, to forgive, to refuse to be bitter, and preach peace and tolerance They are truly inspirational I am sure many will be very inspired to hear their stories how they overcame horrible atrocities and not become victims but victors Sierra Leone Amputee Soccer Players in local school and communityOn May 27th World Harvest and the Sierra Leone soccer players visited ACS Lions in Arcadia, California to present an event-filled day to the middle school students There were about 100 students who were able to interact and listen to the amputees story They sang a song that revolved around peace, and shared the value of nonviolence These amputee players have been through wars and difficult situations, and they know firsthand that war is not the answer During the civil war in Sierra Leone they had their limbs hacked, but they did not allow their physical handicap affect their future The soccer team emphasized the importance of no bullying, no shooting, and no bombs No fighting because violence is not the answer, but peace is the answer Summer Kick Off 2014WorldHarvest had the honor and privilege to host the event, Summer Kick Off 2014 It was amazing seeing the community of Monrovia, California come out and attend our event At the event we had game booths, food, and amputee soccer games with our friends from Sierra Leone Our friends from Sierra Leone not only got to play soccer with our community but also shared their message The amputees were a group of people that had every right to be bitter, angry, and violent They each had suffered from many horrifying situations throughout their lives but instead they share the message of peace They are constantly spreading the word peace and to love one another instead of being violent and hating one another The amputees truly made something that is so tragic, into something that is inspiring Certificate of Appreciation from the Mayor of MonroviaWorld Harvest is honored to be appreciated by the Mayor of Monrovia by receiving a certificate of appreciation for our humanitarian efforts World Harvest is also appreciated by our partner ELI from NY Both organization work together in organizing and accommodating the Sierra Leone Amputee Soccer player World Harvest facilitated them in sharing and motivating in their trip in the United States East Africa Mission Outreach 2014From August 12-20th, World Harvest team traveled to Tanzania, Uganda, and Rwanda to train and equip leaders in Leadership, Community Transformation and Family Around 500 community leaders were trained on how to impact their communities and make a difference in the lives of those who need it most The delegates were extremely excited to have the historical and top leadership of IFGF address them throughout the conference
