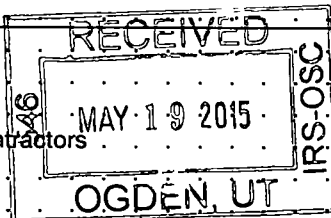

Travel expenses include trips to meetings, conferences, and workshops; to research, monitoring, and restoration sites; as well as travel associated with the development of HMN's programs. The total travel expenses are \$29,595.00.

The second class of expenses include the materials and supplies bought to support HMN's programs. These expenses include office supplies, field research and monitoring equipment, and computer equipment and supplies. The total expense for these supplies is \$3,923.00. The total for these additional expenses \$33,518.00
