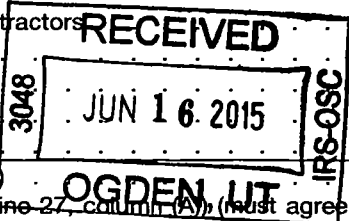

### **PART III - Statement of Program Services**
